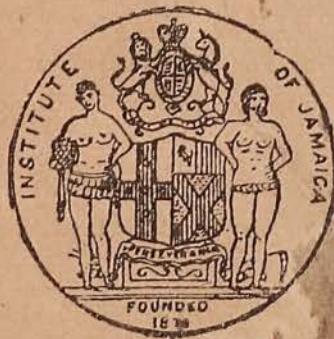

REGULATIONS.

MEMBERS.—The Subscription is ten shillings or (to those who wish to borrow additional books) fifteen shillings; or, in case of Members residing outside Jamaica, five shillings per calendar year, payable on election, and on the 1st of January in each following year.

Members have the right to use the Members Room; to borrow two books (of which one only may be a new book that has been less than six months in the Library) and one magazine from the Library; and to attend, and to bring a friend to Members Meetings. Members who pay fifteen shillings a year are entitled to borrow four books (of which two only may be new) and two magazines at a time.

A reduction in the favour of Members is made in the price of the subscription for the courses of Institute of Jamaica Lectures and Classes. They also receive copies of the current publications of the Institute, either gratis or at reduced prices, and are admitted free to exhibitions held by the Institute.

SUBSCRIBERS TO THE LIBRARY pay three shillings for three months' right to borrow books and magazines on the lines of the ten-shillings-a-year membership, four shillings and sixpence for the facilities of the fifteen-shillings-a-year membership. Unless recommended by a member of the Board, they must make a deposit of ten shillings.

COUNTRY MEMBERS.—Members and Subscribers to the Library can receive and return to the Institute, free by post, books which may be taken to the country for present reading for the sake of improvement (not novels) and certain periodicals.

THE CATALOGUE OF THE LIBRARY, 1895, may be purchased, price 2s. There is also a card catalogue in the Library, kept up to date.

BOXES OF BOOKS.—Boxes of 100 selected books are lent to local institutions and private individuals, in the country, at a charge of £2 10s. (or £1 5s. for the rural districts) per annum, payable in advance. The boxes are exchanged as often as found possible.

THE LIBRARY, READING-ROOM, MUSEUM, AND PORTRAIT GALLERY.—The Library and Reading-Room are open to the public every week-day from 10 a.m. to 5 p.m.; the Museum from 10 a.m. to 5 p.m. (shown only to the public); the Portrait Gallery is temporarily closed.

ART CLASSES.—Art Classes are held in connection with the Institute. Art Lecturer, Mrs. J. A. Allwood (late of the Peterborough School of Art).

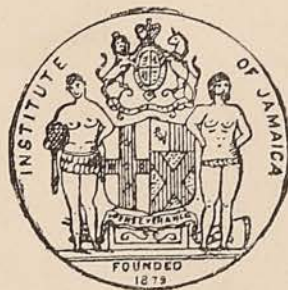

PREFACE.

OWING to lack of funds it has hitherto been found impossible to print the supplement to the printed catalogue of books in the Library of the Institute of Jamaica, which appeared in 1895—the supplement existing only in card-catalogue form, available for use by readers in the Library, but not for those at a distance.

The liberality of a friend of the Institute has, however, rendered it possible to make a beginning with the portion of the supplement connected with Jamaica. It has been considered advisable to print it, not, like the catalogue, in alphabetical order, but like “*Bibliographia Jamaicensis*” in classified form in chronological order; and the opportunity has been taken of adding the titles of those works known to exist but not in the Library (prefixed by a *) which have been ascertained since the publication of “*Bibliographia Jamaicensis*” in 1902. The additions to the Jamaica section of the Library (books and pamphlets) made since 1895 number 1,236. When the library supplement was completed it was thought undesirable to include the entries which appear in “*Bibliographia Jamaicensis*,” and these (to the number of 519) have been eliminated.

The only titles that appear in both works are those which had a * in the “*Bibliographia*” and have since been added to the Library.

The press-marks of books in the Library have been added.

For the sake of economy all titles have been abbreviated. Where the place of publication is not given it is London or, in some cases, Kingston.
